LIVERPOOL GOLF CLUB REWARDS PROGRAM

TERMS AND CONDITIONS

These terms and conditions apply to the Liverpool Golf Club Reward Program.

These terms and conditions overseeing the Liverpool Golf Club Reward program can change at the discretion of management.

Only Financial members of the club who are 18 years of age or older (excluding temporary members) are eligible to participate in Liverpool Golf Club Reward program.

The Clubs employees are not eligible to participate in Liverpool Golf Club Reward program other than existing Full Staff Members as defined by the club's Constitution.

An eligible member who participates in the Liverpool Golf Club Reward program is bound by these terms and conditions. Failure to do so may result in disciplinary action by the board.

The club (including its employees, agents and contractors) has no liability to any person for injury (including death), loss or damage whatsoever, however arising in connection with the promotion

OPTING OUT

If a member does not wish to participate in the reward program they can opt out of the program by informing the club in writing.

Once a member opts out of the program that member will be unable to participate in any of the promotional rewards or benefits offered to Liverpool Golf Club Reward program participants.

The club will take steps to ensure that the former participant does not receive promotional material relating to Liverpool Golf Club Reward program.

EARNING POINTS

A member may only start to earn reward rewards points after:

- An application for membership has been submitted to the club in accordance with the constitution of the club;
- The Board has approved the Member's application; and
- The Member's account has been processed.

All reward rewards points validly earned by a Member will be credited to the Member's account.

A Member may not transfer accrued reward points to any other member of the club.

Only one membership card is permitted per member at any one time.

A card issued to a member may only be used by that member. Any person found to be using another member's card will have all points removed from their account. The member will also face disciplinary action at the discretion of management.

The accrual of or redemption of rewards points in conjunction with any other offer is not permitted unless it is specifically stated by the club for that it will apply for a particular promotion.

Points are earned at a default rate of one point for every one (\$1.00) dollar spent in any one transaction at any POS within the club on beverages or pro shop equipment and merchandise.

Unless as part of a specific promotion, Reward Points cannot be automatically earned for the payment of subscriptions or levies, competition fees, visitor fees, green fees, cart hire, cart storage, locker fees, buggy storage or golf lessons.

The Club may from time to time offer bonus reward points for participating on certain promotions or activities. The duration of any such promotion will be determined by the club and will be final.

A member must produce their membership card at the time of purchase and have it swiped at the Point of Sale (POS) terminal in order to earn reward points. No points will be added at a later date unless there is a technical fault with the Club's own equipment at the time of purchase where points cannot be added onto a member's card.

The club will award reward points directly to the member's reward card once they have participated in any other promotions by way of making a payment to the club where a POS transaction is not possible.

Members may view their Reward Points balance by viewing their account details in the secure Member's Area on the club website.

By participating in Liverpool Golf Club Reward program a Member acknowledges that the club does not accept responsibility and does not accept liability for the theft, loss or misuse of or fault in the Members membership card (including without limitation the failure of the membership card to accrue reward rewards points).

The club reserves the right to decide any matter or settle any dispute arising directly or indirectly out of or in connection to Liverpool Golf Club Reward Program and the club's decision on any such matter or dispute will be final and binding.

LIVERPOOL GOLF CLUB REWARDS PROGRAM

TIER LEVELS

There are three (3) levels of in Liverpool Golf Club Reward program. They are Gold, Silver & Bronze. All eligible members are automatically Bronze level members.

To be eligible for a Silver or Gold membership the member must, within a six month period, earn the published amount of Tier 1 loyalty points.

Members who become eligible for Silver or Gold membership will be issued with a separate membership card that identifies them as either a silver or gold member. This card must be used when redeeming reward points to ensure that the additional discounts are applied to their purchases.

All tier reviews will be undertaken each July and January for the previous six month period.

Once a member has been promoted, they cannot be demoted for another review period or 6 months.

The club retains the right to manually move members into any tier level regardless of the amount of loyalty points a member has earned.

TIER REWARD POINTS

There are two levels of Tier Reward Points which are earned in separate ways:

Tier 1: Reward points earned by the member when purchasing goods and services through the Club POS terminals;

Tier 2: Reward points earned by members when participating in various promotions that are organised by the club from time to time (e.g. early payment of annual subscriptions)

Only Tier 1 points count towards earning Silver or Gold Tier Level status. Tier 2 Points do not count towards Tier Level status but can be redeemed in conjunction with Tier 1 points.

All rewards advertised are correct at time of publication. These rewards are subject to change.

Depending on the member's tier level, additional discounts will be applied when redeeming their points on eligible purchases within the club (see the table below).

All advertised tiering discounts apply to members using their points to pay for the entire purchase. No part payment options will be offered.

Purchases made with reward points cannot be combined with the use of trophy account credits.

All Reward Points will expire on December 31 each year.

PRIVACY

By participating in Liverpool Golf Club Reward Program the participant consents to the club collecting and retaining the Participant's information (including information concerning the Participant's membership) for the purposes of;

- Carrying out the functions and activities that are necessary for the Club to meet its obligations to the Participant under these terms and conditions;
- Disclosing the Participant's personal information to third parties who are engaged by the Club to assist it in meeting its obligations to a Participant under these terms and conditions;
- Marketing the Club's goods and services to the Participant;
- Disclosing the participant's personal information to selected third parties to allow them to market their goods and services to the Participant unless the Participant informs the Club otherwise in writing;
- and Meeting legal requirements or fulfilling any purpose authorised by or under law.

Subject to any applicable law the Club will, at the Participant's request, provide the Participant with access to personal information held by the Club.

If the Participant becomes aware that any personal information held by the Club is inaccurate, incomplete or out of date the Participant must immediately advise the Club to enable the Club to update its records.

The club is committed to privacy and the safeguarding of member, visitor and staff personal information. Further information regarding the Club's Privacy policy is available from the Club on request.

LIVERPOOL GOLF CLUB REWARDS PROGRAM

FREQUENTLY ASKED QUESTIONS

Q: WHEN DOES THE NEW PROGRAM START?

A: The new Program commences on July 1 in terms of redeeming Tier 2 points, although you may continue to earn points under the current program.

Q WHAT ABOUT THE POINTS I CURRENTLY HAVE?

A: Your existing points will carry over to the new program but will not count towards your Tier Status.

Q WHAT IS 'TIER STATUS'?

A: Depending on the number of points you earn in a six month period (either from January to June or July to December), you can become a Silver or Gold member of the Rewards Program. All members automatically become Bronze Members. Members will be assessed each six months to determine their Tier Status and they will remain at that level for the next six months.

Q HOW MANY POINT DO I NEED TO BECOME A SILVER OR GOLD MEMBER?

A:

Q WHAT ARE THE BENEFITS OF SILVER OR GOLD STATUS?

A: When you redeem your points for products at the club, you will receive additional discounts on those products.

Q HOW DO I EARN REWARD POINTS?

A: Points can be earned in two ways:

- i) Simply by swiping your membership card at any Point of Sale terminal when purchasing products at the club (Tier 1 points);
- ii) By participating in promotions at the club where Reward Points are awarded (Tier 2 points).

Q WHAT ARE TIER 1 AND TIER 2 POINTS?

A: Tier 1 points count towards your Tier Status. Tier 2 Points don't count towards your Tier Status, but can be redeemed along with Tier 1 Points.

Q HOW MUCH ARE POINTS WORTH?

A: Points are earned and redeemed at the same rate:
1 Point for each dollar spent at the club on products
\$1 for each 100 points being redeemed on eligible products

Q HOW CAN I FIND OUT HOW MANY POINTS I HAVE?

A: You can find your points balance in the secure Members' Area on the website, right below your trophy account balance. You can also enquire at any Point of Sale terminal by having your card swiped by a staff member.

Q WHAT CAN I SPEND MY POINTS ON?

A: Points can be redeemed on any products purchased at the bar or in the pro shop. Points cannot be redeemed to pay for Subscriptions, levies, member events, competition fees, green fees, cart hires cart storage, locker fees, or golf lessons. Points cannot be used to purchase food items at the members' bistro.
